



Q4 Do you have the responsibility for supervising or managing the work of lawyers or other employees?



Q5 Age: From the list of age bands below, please indicate the category that includes your current age in years










Q9 Are your day-to-day activities limited because of your health problem or disability which has lasted, or is expected to last, at least 12 months?






Q12 Sexual Orientation: What is your sexual orientation?



Q13 Socio-economic background: If you went to university (to study a BA, BSc course or higher), were you part of the first generation of your family to do so?





Q14 Did you mainly attend a state or fee-paying school between the ages 11 - 18?




